It has been brought to my attention that there has been a change in Smart Choices Healthy Food and Drink Strategy for implementation from the beginning of Term 2.

The three major changes are:

- The only drinks to be sold in schools are plain water, milk (plain or flavoured) and 99%-100% non-carbonated fruit or vegetable juice.
- All potato chips and similar snacks will be classified as RED

All products with added confectionary, icing and sweet fillings will be classified as RED

This will impact our tuckshop immensely.
